**FRAMEWORK AGREEMENT**

**University of Vlora "Ismail Qemali" (Albania)**

**and**

Proceeding from the common interest in the development of education and academic cooperation at both institutions and the endeavours to broaden the contacts between them,

The University of Vlora "Ismail Qemali", represented by Prof. Dr. Aurela Saliqaj, Rector, is a public institution, having legal status, created pursuant to the article 57, paragraph 7 of the Albanian constitution and the law 80/2015 «On the higher education and scientific research in the institutions of higher education in the Republic of Albania»; The University of Vlora "Ismail Qemali" has been founded with the Council of Ministers Decision Nr. 105 date 28.02.1994.

The University of Vlora "Ismail Qemali" has the competence to attend to public service in the fields of the higher education and scientific research, also establishing relationships with other academic, cultural and scientific institutions, either Albanians or from other countries;

**to sign a Framework Agreement of cooperation based on the following articles:**

**ARTICLE 1**

The Institutions determine and regulate with this agreement the areas of mutual cooperation as well as the forms and ways of its implementation.

## ARTICLE 2

Cooperation shall be undertaken through such activities or programs which relate to:

1. Exchange of academic information, publications, and research materials.
2. Collaboration in academic programs, training, and professional development.
3. Exchange of faculty members, researchers, and students, subject to the regulations of each institution.
4. Development of joint research projects and educational initiatives.
5. Campus visits by prospective students and academic representatives from India to explore educational opportunities and institutional facilities.
6. Any other activities mutually agreed upon by both institutions.

## ARTICLE 3

Based on this agreement, the respective University authorities will determine the acts and procedures for carrying out the activities.

## ARTICLE 4

Each party shall nominate a liaison person to coordinate the implementation of the activities.

## ARTICLE 5

The implementation of the activities defined in Article 2 of this Agreement depends on the availability of funds for such kind of joint activities.

All commitments, obligations and expenditures related to projects approved under this agreement shall be administered in accordance with each university's practices and policies and the specific terms and conditions of the funding agencies.

## ARTICLE 6

The Institutions agree that, for reasons of force majeure or other unavoidable causes which create an objective impossibility of fulfilling the obligations of each party, this impossibility will not be considered as a reason for the termination of the agreement.

## ARTICLE 7

1. Possible amendments and additions to this agreement will be formulated and submitted in written form and will be part of an annex to the agreement.
2. This agreement enters into force upon signature by the respective legal representatives of both Institutions and is valid for a period of 5 (five) years from the signing date.
3. The term of this agreement may be extended based on a joint written agreement.
4. This framework agreement can be resolved if each of the .....submits 6 (six) months in advance of a written request addressed to the partner University.

**ARTICLE 8**

Made in Vlora on 03.04.2026 in two identical copies each in Albanian and English language.  
In case of any divergence of interpretation, the English language version shall prevail.
