#### Abstract and publication criteria

Title and personal information of Author(s) have to precede the abstract, written exclusively in English language, which has to be sent to: <u>ius.conference2018@univlora.edu.al</u> before May 15<sup>th</sup>, 2018. All abstracts have a limit of 500 words (excluding title and authors' information). If you exceed the character limit, we will turn back the abstract for correction. Graphics or tables cannot be accepted because of production limitations. Abstract titles should be in lower case, except the first word, abbreviations and countries. Do not use capital letters only and avoid using abbreviations or acronyms. Give geographic location and dates if applicable. In the abstract, please indicate the relative topic code (IUS).

Author and co-author: you can include up to 3 co-authors. Please follow the instructions carefully by adding, last name, first name, institute, town, country of each author. Please make sure that you use the English version of the institute, town and country. Spell out the full name of the institution and do not use abbreviations such as 'Univ.' for 'University'. The full paper will be submitted before June 15<sup>th</sup>, 2018 in English or Italian language. Conference language will be English and/or Italian during the first day panels (24 May), and Albanian during the second day panel (25 May).
